- 3s and Pre-K children must be enrolled in a class dismissing at 2 p.m. to participate
- An afternoon snack is provided
- Includes outside play, weather permitting
- Child will be offered a daily rest time
- This program follows the school calendar and closures
- Last day is Tues., June 3, 2025

## Financial

Parents whose children attend TRS Early Childhood Center (TRS ECC) have the option to register for programs extending the day. Registration is for the entire school year, beginning on the child's first full day of attendance. Registration is on a first-come, first-served basis. *Space is limited. Space permitting, mid-year enrollments are allowed.*

- Payment will be made from your account as specified on your *Automated Payment Authorization for Tuition and Other Fees Form* on file by electronic debit transfer from your checking account (no fee) or by credit card (2.8% + \$.15 flat fee).
- The program will be billed in three equal payments: a deposit due with the registration, with additional payments due (on or after) August 30, 2024 and January 30, 2025.

### Drop-In (\$20/session for early morning or afternoon until 3 p.m.)
